Or does this also include promoting the before mentioned via a social media channel?	Just for clarification I believe Rafael spoke to this point. Prior notification is required when media is involved. An email to Shantel High, Autruse Wilson and Toni Terry is required 10 days prior for such things as a personal interview, publishing in the local newspaper, radio advertisements or when press releases are required. You can always refer to the boiler plate language in your contract for specific guidance.	IDHS
	Is 70% the new standard for IYS recruitment? I did not see this standard listed on our FY21 contract. Is it 70% of the schools listed on our universe or based on school populations?	The goal for IYS recruitment is "increase and/or maintain IYS participation of all of the public schools, at minimum, in the IYS Universe to ensure that at least 70% of the students at each grade (8th, 10th, and 12th) participate." 	I noticed that Rafael mentioned that our prevention services now go from Universal, which we have mostly focused on, all the way to include Selective and Indicated populations (around 4-5 min mark in webinar). 	<p>My question is regarding YPE. Rafael mentioned “keep adaptations that are working”. I am now the only Prevention staff covering 2 grades in 5 school districts. Scheduling is very difficult. I hope I will be able to reach all of my students if I continue sending my videos of me teaching the lessons to at least one of my schools. I understand it is not optimal, but I may have to drop a school from my YPE workplan since I am the only staff. I don’t really want to do that. During Covid, my part-time educator left the position, and it currently is not in the budget to hire another person. I will talk to Shantel as well, but I thought perhaps someone else has this dilemma and could use an answer too.</p>	<p>This is an adjustment to a specific situation using a previously accepted adaptation. I recommend you reach out to Shantel for consultation and approval. With that being said we all know we had to make some modification to programing in FY21 due to Covid related issues. As we enter into FY22 things may still look a little different but we are working back towards a more normal way of doing things. If your agency implemented adaptations to YPE or programing in FY21 such as but not limited to, videos instead of in-person, condensed sessions and materials, primary and secondary cc messaging and such please contact Shantel for review and recommendations for moving forward in FY22. Do not assume since the modification was approved in FY21 that it is approved for FY22. We highly recommend if you are able to get back in the classrooms that you implement programing in person as recommended by developers.
