OVERVIEW

The Alcohol Policy Resource Center expanded its presence nationally in FY24. This expansion included presenting a workshop at the National Prevention Network (NPN) Conference in partnership with the Illinois Liquor Control Commission's Division of Enforcement. This partnership continues to grow through additional conference presentations and hosting 10 law enforcement trainings. The APRC presented at four additional conferences throughout Illinois. We exhibited at seven conferences, including the NPN Conference in Birmingham, Alabama. The APRC continued our commitment to high-quality webinars with national experts in the field, facilitating four this fiscal year. This fiscal year, the APRC was a featured webinar expert discussing how to conduct environmental scans. The APRC Environmental Scan Toolkit was the showcased resource of the webinar, which was co-facilitated in partnership with Counter Tools. The APRC partnered with the Cannabis Policy Resource Center to host a one-day training workshop featuring Jermaine Galloway for nearly 200 coalition members, enforcement officers, and other prevention-based providers.

WEBINARS

The APRC coordinated with national experts to share the latest research and strategies to prevent underage drinking.

Four webinars were conducted during FY24:

- <u>Environmental Scans for Alcohol Policy Change</u>, facilitated by Jody Heavilin, APRC Administrator & Maria Julian, Executive Directive, Counter Tools.
- <u>Changing Patterns of Alcohol Use By Girls and Young Adult Women</u>, facilitated by Dr. Aaron White, Senior Scientific Advisor to the Director and Leader of the Epidemiology and Biometry Branch at the National Institute on Alcohol Abuse and Alcoholism.
- Alcohol Misuse as a Risk Factor for Gun Violence, facilitated by Joshua Horwitz, J.D., Dana Feitler Professor of the Practice in Gun Violence Prevention and Advocacy at the Johns Hopkins Bloomberg School of Public Health and the Co-Director of the Johns Hopkins Center for Gun Violence Solutions, and Silvia Villarreal, Director of Research Translation at the Center for Gun Violence Solutions and the Managing Director for the Consortium for Risk-Based Firearm Policy.
- <u>Deaths From Excessive Alcohol Use on the Rise in the US</u>, facilitated by Dr. Marissa Esser, Lead of the Alcohol Program at the Centers for Disease Control and Prevention in the National Center for Chronic Disease Prevention and Health Promotion.

Webinars enable the APRC to provide evidence-based information to a broad audience in a live and on-demand format. All webinars are recorded and posted on the APRC's Recorded Webinar page.

LAW ENFORCEMENT TRAINING

The Alcohol Policy Resource Center has partnered with the Illinois Liquor Control Commission Division of Enforcement to provide Illinois Law Enforcement Training and Standards Board-Certified (ILETSB) Alcohol Compliance Check training to law enforcement throughout Illinois. This training meets the 4-hour statutory requirement, giving law enforcement 1 hour for procedural justice and 1 hour for legal updates (mandatory training hours). All training is scheduled through local ILETSB Mobile Team Units (MTU). The largest MTU in Illinois is the North East Multi-Regional Training, Inc. or NEMRT, which serves Cook, DuPage, Kane, Kendall, Lake, and McHenry Counties. NEMRT has placed the APRC/ILCC Alcohol Compliance Check Investigation training as a reoccurring course offering in their fall, winter, and spring catalogs. The APRC/ILCC trained 134 officers this fiscal year. The trainings were held in McHenry, McCook, East Moline, Streamwood, Frankfort, Lemont, Peoria, Crystal Lake, Calumet Park, and Belleville.

RESOURCES & TOOLS

Resources and tools allow the APRC to deliver capacity-building information directly to municipal leaders, law enforcement and coalition members. Resources and tools are available on the APRC website, distributed at meetings and conferences and uploaded into webinars. We often receive requests for materials to distribute through the APRC Clearinghouse, and we can provide resources through grant funds. The Clearinghouse has provided substance use prevention grantees an opportunity to share APRC printed resources with their coalition and the population they serve. Resources are also available in the Springfield and Chicago office.

- Coalition website link




TECHNICAL ASSISTANCE

Technical assistance is provided to communities, law enforcement and municipal leaders to increase their capacity to implement evidence-based alcohol policies and law enforcement strategies. Technical assistance can be a one-time event or support offered over several weeks or even several months. In FY24, ten technical assistance clients received services. Technical assistance topics included:

WORKSHOPS



The Alcohol Policy Resource Center partnered with the Cannabis Policy Resource Center to host the High in Plain Sight training with Jermaine Galloway on June 12, 2024. Jermaine covered current substance use trends, including alcohol, cannabis, and vaping. This free workshop trained nearly 200 prevention providers, coalition members, law enforcement officers, probation officers, school administrators, treatment providers, nurses, health care workers, and counselors. Officer Jermaine Galloway, known as the "Tall Cop," is a nationally and internationally recognized presenter, five-time national award winner, international award winner, and resource for those involved with prevention, education, treatment, and enforcement.

CONFERENCES, EXHIBITS & MEETINGS

Conferences, exhibits, and meetings allow the APRC to reach members of our target audiences and discuss services offered. They also offer resources to municipal leaders, law enforcement, community members, youth and coalition members. Depending on the conference, exhibit or meeting, we customize materials for distribution, based on resources and tools to build capacity for alcohol policies. We also promote technical assistance, webinars and law enforcement training.

The APRC provided meeting coordination and agenda development and helped facilitate Illinois Alliance on Reducing Youth Substance Use meetings. In collaboration with the Illinois Department of Human Services, Division of Substance Use Prevention and Recovery, the Illinois Alliance provides stakeholders working to reduce underage drinking a community of peers who share data, current research, best practices and ongoing underage drinking prevention efforts implemented in the Illinois. The Illinois Alliance also offers an opportunity to review the Illinois STOP Act report. Four virtual meetings were held during the fiscal year.

The APRC is a member of the American Public Health Association - ATOD Leadership Team's Alcohol Action Network (AAN). The AAN meets twice monthly with alcohol prevention leaders from across the country. This group shares resources, experiences and knowledge on topics such as cocktails-to-go, alcohol home delivery, curbside delivery and alcohol taxes.

The APRC serves all of Illinois, and in-person coalition meetings would be nearly impossible. Virtual meeting platforms have opened doors to coalitions all across the state. We have participated in local coalition meetings throughout the year to assess prevention providers' needs and develop working relationships. The APRC actively participates in the Illinois Prevention Network (IPN), a coalition of Illinois coalitions. IPN meets monthly and has a newly formed alcohol subcommittee. The APRC is a member of the alcohol subcommittee.
