MEETING MINUTES

10:30 - 10:40 AM Shantel High

Opening remarks, review the purpose of the Illinois Alliance & synopsis of the December 9th meeting. Updates on STOP Act report due June 2021.

10:40 - 10:45 AM Jody Heavilin

Welcome, brief introductions, and review of reports to be presented at this meeting.

10:45 – 10:55 AM Lee Roupas – Illinois Liquor Control Commission Lee provided information about Responsible Beverage Service in IL. Illinois passed a law in 2015 that required all on-premise alcohol servers (and those required to check IDs for alcohol service) must have BASSET (beverage alcohol sellers and servicers education and training) training. Counties throughout Illinois moved forward with BASSET, and as of July 1, 2018, all counties should comply with this law. Lee noted that BASSET is not required for off-premise locations (i.e., package liquor stores, gas stations, supermarkets, liquor stores). Off-premise locations can be problematic for underage drinking and ease of access. For those communities where home rule applies, municipalities can create ordinances with stricter requirements than the state law. Mayors, liquor commissioners, and councilpersons can make ordinances that require off-premise retailers to be held to the same standard as on-premise retailers.

10:55 – 11:00 AM Robyn Block – Prevention First - Youth Prevention Resource Center Robyn provided the link for the new YPRC website page. To view the website page, click here. Robyn noted the first YPRC newsletter was out and that resources are being released regularly. Recruiting for the Student Advisory Board (SAB) continues, and applications are due April 10. Students will be notified by April 15 if they are selected to be an SAB member. Robyn reviewed the four cornerstones of the YPRC: substance misuse, teen traffic safety, mental health and wellness, and youth leadership development. Robyn shared that the YPRC will offer Youth Mental Health First Aid Training on April 30, May 14, and June 4. There is a 2-hour self-paced class that is a prerequisite for training. 11:00 – 11:10 AM Kerri Viets – Tazewell County Health Department

January 2021 marked the 32nd annual Tazewell County Teen Conference! It looked a little different this year as it was a VIRTUAL conference due to COVID-19. The Teen Conference is planned and run by the Tazewell County Youth Board (TCYB), founded in 1991 by the Tazewell County Health Department.

TCYB is composed of students from all Tazewell County high schools. Members agree to follow a code of conduct year-round to remain substance-free in both their public and private lives. The Board is trained annually on group facilitation, teamwork, and leadership skills. TCYB members plan the Conference and facilitate many of the workshops. TCYB members also develop the theme, t-shirt design, skits, selects workshop topics, and suggest speakers.

At the beginning of the 2020-2021 school year, TCYB began meeting virtually. After the first conference call with the students, it was clear TCYB needed a purpose as a group and to feel like they were making a difference for their peers amid the pandemic. They talked about topics that they felt were most important that their peers were dealing with to help them through this time, including mindfulness, motivation, mental health, and staying positive. Utilizing youth board members, previous Teen conference speakers, and previous keynote speakers, videos were created to be sent to school contacts and made available to students. So far, 506 students have watched the videos. Kerri plans to continue communication with the schools to encourage the use of the videos.

11:10 - 11:20 AM - Scott Hayes - CPRD

Scott overviewed the EYPC (Engaging Youth for Positive Change) program. EYPC is a program that targets youth ages 13-18 to become involved in civic engagement and to learn, participate in, and change a local health-related policy. The program uses a 16-week curricular model, and alcohol ordinance materials are available through the EYPC program. Scott noted EYPC is best suited for an in-class format. Additionally, Scott provided updates on the Illinois Youth Survey. The 2020 IYS community-type reports will be active soon. The community-type reports include suburban Chicago counties, Urban/Suburban counties, and rural counties. These reports can be used to compare statewide data to school, district, county, and community area frequency reports. There will not be a City of Chicago report due to low sample numbers, but some data will be available for Chicago. Scott encouraged Illinois Alliance members to review the White Papers and Infographics based on 2018 survey data. There are White Papers focused on youth alcohol, vaping, and marijuana use in Illinois. To view the White Papers and Infographics, click here.

Lastly, Scott noted that questions specific to bullying will be coming soon to the IYS and could draw schools to take the survey if they are interested in data other than substance use.

11:25 AM – 11:30 AM – Kelly O'Connor – Oak Park Township

Kelly shared the success that Oak Park Township has achieved by implementing alcohol compliance checks. Kelly noted that it was back in 2010 when community members reviewed IYS data, and a conversation ensued regarding retail alcohol access. It took about 5-6 years for community members to find their footing. With the help of an SPF grant,

strengthened partnerships, and strong law enforcement involvement, compliance checks became a strategy of interest. April activities to support Alcohol Awareness Month will center around webinars, reach out to the Chamber of Commerce, and partner with law enforcement. Kelly concluded her overview by focusing on the importance of relationships, youth partnerships, and collaboration.
