I. McHenry County Dispensary Messaging Negotiations

Dispensaries negotiated with: RISE, Ivy Hall

Most McHenry communities used the model ordinances

The Cannabis Regulation and Tax Act (CRTA) prohibits cannabis licensees from claiming any therapeutic/medical benefits of retail cannabis. State's Attorney office found many marketing/advertisting materials that had statements which appeared to be in violation. For example, statements that certain strains would treat certain issues or provide certain health benefits.

Used a civil suit to address violations of CRTA & deceptive practices act. Dispensaries agreed to a settlement to scrub websites of therapeutic statement for recreational. Agreed to put up conspicuous signs: FDA has not approved for any condition. Link between cannabis and certain mental health disorders. \$100,000 to run a cannabis educational campaign in and around McHenry county.
